

UC Davis Material Transfer Agreement for the Transfer of Wheat DNA

In response to the RECIPIENT'S request for the DNA of tetraploid wheat TILLING population and DNA of hexaploid wheat TILLING population and Seeds of selected tetraploid and hexaploid wheat mutants (hereinafter "MATERIALS"), the RECIPIENT and the RECIPIENT SCIENTIST agree to the following:

1. The above MATERIALS are made available as a service to the research community.

5. The RECIPIENT agrees to acknowledge the source of the MATERIALS in any publications reporting use of it.

THE PROVIDER MAKES NO REPRESENTATIONS AND EXTENDS NO WARRANTIES OF ANY KIND, EITHER EXPRESSED OR IMPLIED. THERE ARE NO EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR THAT THE USE OF THE MATERIALS WILL NOT INFRINGE ANY PATENT, COPYRIGHT, TRADEMARK, OR OTHER PROPRIETARY RIGHTS.
